1057 1. Claims

1058 Question: Do the main claims made in the abstract and introduction accurately reflect the
1059 paper's contributions and scope?

1060 Answer: [Yes]

1061 Justification: The main proposed methods and contributions are highlighted in abstract and
1062 introduction.

1063 Guidelines:

- 1064 • The answer NA means that the abstract and introduction do not include the claims
1065 made in the paper.
- 1066 • The abstract and/or introduction should clearly state the claims made, including the
1067 contributions made in the paper and important assumptions and limitations. A No or
1068 NA answer to this question will not be perceived well by the reviewers.
- 1069 • The claims made should match theoretical and experimental results, and reflect how
1070 much the results can be expected to generalize to other settings.
- 1071 • It is fine to include aspirational goals as motivation as long as it is clear that these goals
1072 are not attained by the paper.

1073 2. Limitations

1074 Question: Does the paper discuss the limitations of the work performed by the authors?

1075 Answer: [Yes]

1076 Justification: The limitations are discussed in the section **5. Conclusion and Discussion**,
1077 with insight toward future works.

1078 Guidelines:

- 1079 • The answer NA means that the paper has no limitation while the answer No means that
1080 the paper has limitations, but those are not discussed in the paper.
- 1081 • The authors are encouraged to create a separate "Limitations" section in their paper.
- 1082 • The paper should point out any strong assumptions and how robust the results are to
1083 violations of these assumptions (e.g., independence assumptions, noiseless settings,
1084 model well-specification, asymptotic approximations only holding locally). The authors
1085 should reflect on how these assumptions might be violated in practice and what the
1086 implications would be.
- 1087 • The authors should reflect on the scope of the claims made, e.g., if the approach was
1088 only tested on a few datasets or with a few runs. In general, empirical results often
1089 depend on implicit assumptions, which should be articulated.
- 1090 • The authors should reflect on the factors that influence the performance of the approach.
1091 For example, a facial recognition algorithm may perform poorly when image resolution
1092 is low or images are taken in low lighting. Or a speech-to-text system might not be
1093 used reliably to provide closed captions for online lectures because it fails to handle
1094 technical jargon.
- 1095 • The authors should discuss the computational efficiency of the proposed algorithms
1096 and how they scale with dataset size.
- 1097 • If applicable, the authors should discuss possible limitations of their approach to
1098 address problems of privacy and fairness.
- 1099 • While the authors might fear that complete honesty about limitations might be used by
1100 reviewers as grounds for rejection, a worse outcome might be that reviewers discover
1101 limitations that aren't acknowledged in the paper. The authors should use their best
1102 judgment and recognize that individual actions in favor of transparency play an impor-
1103 tant role in developing norms that preserve the integrity of the community. Reviewers
1104 will be specifically instructed to not penalize honesty concerning limitations.

1105 3. Theory assumptions and proofs

1106 Question: For each theoretical result, does the paper provide the full set of assumptions and
1107 a complete (and correct) proof?

Guidelines:

- The answer NA means that the paper does not include theoretical results.
- All the theorems, formulas, and proofs in the paper should be numbered and cross-referenced.
- All assumptions should be clearly stated or referenced in the statement of any theorems.

4. Experimental result reproducibility

Question: Does the paper fully disclose all the information needed to reproduce the main experimental results of the paper to the extent that it affects the main claims and/or conclusions of the paper (regardless of whether the code and data are provided or not)?

Justification: The methodology is described in details in section 3. **Method**, with all the technical details provided in appendix **B. Implementation Detail**.

Guidelines:

- The answer NA means that the paper does not include experiments.
- If the paper includes experiments, a No answer to this question will not be perceived well by the reviewers: Making the paper reproducible is important, regardless of whether the code and data are provided or not.
- If the contribution is a dataset and/or model, the authors should describe the steps taken to make their results reproducible or verifiable.
- Depending on the contribution, reproducibility can be accomplished in various ways. For example, if the contribution is a novel architecture, describing the architecture fully might suffice, or if the contribution is a specific model and empirical evaluation, it may be necessary to either make it possible for others to replicate the model with the same dataset, or provide access to the model. In general, releasing code and data is often one good way to accomplish this, but reproducibility can also be provided via detailed instructions for how to replicate the results, access to a hosted model (e.g., in the case of a large language model), releasing of a model checkpoint, or other means that are appropriate to the research performed.
- While NeurIPS does not require releasing code, the conference does require all submissions to provide some reasonable avenue for reproducibility, which may depend on the nature of the contribution. For example

 - (c) If the contribution is a new model (e.g., a large language model), then there should either be a way to access this model for reproducing the results or a way to reproduce the model (e.g., with an open-source dataset or instructions for how to construct the dataset).
 - (d) We recognize that reproducibility may be tricky in some cases, in which case authors are welcome to describe the particular way they provide for reproducibility. In the case of closed-source models, it may be that access to the model is limited in some way (e.g., to registered users), but it should be possible for other researchers to have some path to reproducing or verifying the results.

5. Open access to data and code

Question: Does the paper provide open access to the data and code, with sufficient instructions to faithfully reproduce the main experimental results, as described in supplemental material?

6. Experimental setting/details

Question: Does the paper specify all the training and test details (e.g., data splits, hyper-parameters, how they were chosen, type of optimizer, etc.) necessary to understand the results?

Justification: The methodology is described in details in section **3. Method**, with all the technical details provided in appendix **B. Implementation Detail**.

Guidelines:

- The answer NA means that the paper does not include experiments.
- The experimental setting should be presented in the core of the paper to a level of detail that is necessary to appreciate the results and make sense of them.
- The full details can be provided either with the code, in appendix, or as supplemental material.

7. Experiment statistical significance

Question: Does the paper report error bars suitably and correctly defined or other appropriate information about the statistical significance of the experiments?

Justification: The statistical analysis is provided in appendix **D. Statistical significance on the model comparison**.

Guidelines:

- If error bars are reported in tables or plots, The authors should explain in the text how they were calculated and reference the corresponding figures or tables in the text.

8. Experiments compute resources

Question: For each experiment, does the paper provide sufficient information on the computer resources (type of compute workers, memory, time of execution) needed to reproduce the experiments?

Guidelines:
